Synopsis: To provide a summary of information developed to date in this private investigation.

Details: The following information was developed concerning the above-captioned case:

Introduction

I am a lawyer in California (license no. 237990), and I conduct private investigations pursuant to Business and Professions Code sec. 7522(e) and 7582.2(e). These statutes exempt attorneys from the private investigator licensing law.

I also represent professional actress and model in her legal matters. Ms. asked me for help with this incident, which I investigated in an effort to facilitate the filing of a police report by Ms.

Incident Summary

On June 22, 2020, amateur photographer Jordan Eisman (male/

white/40 years old) of Los Angeles hired Ms. for a photo shoot. The parties agreed in advance that this would be an "artistic nude" photo shoot with no revealing photos of Ms. 's vagina. Despite this, Eisman took numerous explicit photos of Ms. 's intimate parts without her consent, posted them on Instagram, and then attempted to blackmail Ms. into paying him \$100 to remove the photos that included her vagina. He then harassed her with threatening text messages and calls and refused her requests to cease and desist. During the investigation, he admitted he is mentally ill and suicidal, and he also threatened to kill himself in front of me and my assistant at our office. I would recommend that Eisman be arrested and charged under the new "revenge porn" law as well as the laws against extortion and criminal threats, and possibly the anti-stalking law. In addition, Eisman appears to be an appropriate case for a 5150 psychiatric evaluation.

Detail

Ms. related substantially the following in a telephonic interview conducted under my supervision:

On June 22, 2020, Eisman contacted Ms. Ithrough Ms. 's Instagram page. He asked if she would like to participate in a photo shoot at his apartment. Jordan's apartment was located at 3533 Keystone Avenue in Los Angeles. He initially asked if he could pay \$100 an hour for two hours of modeling for erotic/nude/lingerie photos. Ms. replied that she does not do erotic photos, but occasionally she would shoot "artistic nudes" and her rate for the artistic nudes would be \$200 per hour. Eisman replied that that was fine. They coordinated a good time to do the photo shoot, and it ended up being that same day on June 22, 2020.

During the initial call before Ms. arrived, Eisman laid out what he expected, which was "art nudes" in various poses.

Ms. agreed with some caveats, and she did specifically state she would not spread her legs, and that there could be no shots of her vagina. She said multiple times that it had to be "artistic" and not in the realm of pornographic; he agreed and he said that that was all totally fine. Eisman said "consent is the most important part of this" and that he wouldn't shoot anything that Ms. was uncomfortable with. Although he stated in the phone call that he has a sort of "pervert energy," Eisman asked Ms. to please not be offended or take that the wrong way. He stated he really just wanted to create art and that he loves to shoot naked women. Ms. is a model/actress so she has occasionally done artistic nudes in the past, but she has never encountered the issues she encountered with Eisman.

Upon arriving at Eisman's apartment at 2 o'clock in the afternoon, they started taking photos in his apartment, hallway, and outside his apartment. Eisman took numerous photos of Ms.

in many different places and positions. Throughout the photo shoot, she had to tell Eisman numerous times: "no shots of my pussy." He would reply (for example) "oh of course not! It's my angle-- don't worry, you can't see anything." Eisman repeatedly reassured Ms. that consent was important to him.

While she was laying on the bed, he came to take photos of her hip bones and she again stated "hey no shots down there, remember?" He then replied: "I know, I just love taking photos really close of specific body parts like hips--that to me is very artsy. But I am only getting your hip bones in the shot." Upon concluding the photo shoot, he told her he would edit about 15 photos and send them to her prior to posting them.

The next day on June 23, 2020, Eisman did send Ms. some photos, but she did not get a chance to look at them closely. Later that night is when she became aware of the distasteful and non-consensual photos that he posted on his Instagram page. She became aware through Instagram due to the fact he tagged her in the photos. Upon going on his Instagram, she discovered at least two photos that he posted that she did not give him consent to take or post. She stated that you can actually see her vagina in the photos and they specifically agreed to have "no vagina" in any of the photos. She then sent Eisman a private message via Instagram with those two photos attached, and asked politely if he could remove them because she did not give him consent to post those. Eisman texted her back five minutes later stating he would not remove the photos unless she paid him \$100. After that message he then sent Ms. approximately eleven text messages with vulgar slurs and inappropriate language. One text stated: "I'm really getting tired of you fucking models. I'm an idiot for thinking you were any different from all the others." After a further exchange, Eisman responded saying "I deleted the photos you crazy ass bitch." He also said "filing a police report laughing my ass off you know I was a kid in school who never listened to authority. In fact, if I didn't have sports injuries, believe me I would be marching with protesters and probably setting shit on fire so I have a really hard time being told what to do."

After this conversation, Ms. I looked again on his Instagram, again finding that the offending photos were not deleted as he had claimed. Ms. I said that she reported the photos to Instagram, and after that happened he made his account private. She said once the account had been made private she asked one of her friends to see if she could go on his profile, to possibly see if the pictures of her were still posted on his page. During this time he kept texting her repetitively, to the point where she had to tell him "you'll be hearing from my lawyer and I will be going to the police, we do not have a signed contract and it's illegal for you to have those photos of me without my consent." He then replied to her asking how she has the nerve to ask him to wear a mask during the photo shoot and that she is just "bat shit crazy." He also stated

that the police would probably just laugh at her and that he did not have time for this--he has 1,000 more pictures of her to post. During the text conversation, Jordan then insinuated that he knew the photos would be damaging to Ms. 's career. He also approximately an hour later messaged her a video of himself scrolling through all the pictures he took that included her vagina, which they both agreed he would not do. He then stated "look at all these photos I have of you, I can post them all." After sending this video he still continued to text her and call her inappropriate names. He also texted her: "I'm going to give you like 24 hours to make up your mind because this won't be on the table forever." He was referring to the offer to take down the photos for \$100. He then again messaged her "if you want the photos removed refund my hundred dollars or they stay up. It's that simple. I'm not getting into a power struggle with you, I'm not gonna feel threatened by you, and you're not gonna be a Karen and call the fucking police."

On Wednesday June 24, 2020, the same day, Eisman continued to text Ms. ____, at this time she stopped responding to him altogether. That evening on the 24th he messaged her: "Karen your offer will expire. You do have a great bush though." The exchange continued with Eisman again offering to take the photos down for \$100.

On Thursday, June 25, 2020, Ms. received a random text message at 7:06 a.m. from a number she did not recognize. that text message were some of the explicit photos of Ms. When she texted back the number asking who the sender was, they replied by stating "a friend of the photographer." She then texted that number as well: "stop harassing me." But they did not stop; they went on to say: "so you don't want the photos taken down?" She responded to that message by stating "yes, and I've already asked you. I don't know what kind of person you are getting off on tormenting women that work for you, but I am not going to be blackmailed." They again replied to her that all she has to do is send the money if she wants the pictures taken down. Eventually, the unknown number texted her: "your daddy trained you well-- never give in to the Jew."

This whole experience has caused severe emotional distress as well as a strain on her relationship with her significant other. She also had a music video that she was working on during this time and was not able to give it her full attention. She has potentially lost a lot of business due to this incident, because she will no longer be doing any of this level of photo shoots. Photo shoots are a big part of her income, and she has also had to turn down a movie role due to being too traumatized by this incident. She feels that Eisman lures women to his photo shoots in order to extort them and/or for perverted personal reasons. He had stated in the beginning of their interactions that he wanted to take as many pictures of naked women as possible to make an ex-girlfriend/model jealous. However, Ms. did not believe it was her place to question

his personal motivations, so she proceeded with the photo shoot even though there was this one red flag.

Eisman related substantially the following in a voluntary telephonic interview that I conducted:

Eisman said he was surprised that Ms. hired us and immediately stated that he wanted to keep us on the phone as long as possible in order to cost Ms. more money. We asked if we could record Jordan, and he declined, so we did not record the call. However, Eisman agreed to keep talking to us so long as we were not associated with law enforcement. I explained this is a civil investigation at this point, and we are not associated with law enforcement. The rapid flow of the conversation was such that Eisman was unwilling to listen to much of what we said, but I attempted to warn Jordan that anything he said could be used against him and this was voluntary on Eisman's part. Eisman did not heed the warning (to the extent he heard it), and he engaged in a lengthy presentation that was mostly him talking, much of which was out of order. I offered Eisman the opportunity to review his statement before it was finalized, and Jordan angrily declined, but kept talking.

Eisman paid Ms. to take nude photos of her on June 22, 2020. He stated he had her consent and there was no physical contact at all. He also stated that as of now, he has taken off all the pictures from his Instagram that she asked him to remove. He also stated that he would have no problem removing any additional photos at her request; he said he had already removed the two photos that she said that were distasteful. Eisman said that upon the initial contact from Ms. him to take down the photos, he asked for a \$100 refund to take down the photos because he did not get what he paid for. he took them down anyway without receiving the refund. understanding, Ms. agreed that he could take nude pictures of her and her vagina for \$200 an hour--the only stipulation was that she would not be doing pornographic photos such as spreading her genitalia i.e. "pussy lips," which is what he would consider to be pornographic. He said during the time that she was at the apartment and taking photos for him, he did show her a couple of the photos and she had no objections. He also stated that he offered to show her all the photos at the end of their session but she declined. He said he does not remember how many photos he took of Ms. Eisman also stated that they had a prior conversation before her arrival stating that he did want pictures of her vagina and he would like her to be shaved. She allegedly responded by saying that she was not "fully groomed down there," but he would see upon her arrival at his apartment."

Eisman said that Ms. started contacting him after the photo shoot due to the fact that her boyfriend was upset and wanted the pictures taken down. To Eisman's understanding, the boyfriend did not know what Ms. was doing, and when he found out he got upset. That's why Eisman believes Ms. asked

for the pictures to be taken down. He did inquire as to whether we had seen payment receipts or the actual messages that were on Instagram. We said we had not, although we had of course talked to Ms. and were not authorized to release any of that information. Eisman stated that he deleted all his messages on Instagram and that he did not think that Ms. was smart enough to know that Instagram messages can be retroactively deleted.

Eisman stated that he has worked with 32 models and has been in the field for one year, and he has never had any issues pertaining to this before. He also stated that his father has been in the photography industry for 50 years. He said he paid Ms. In full via PayPal. He asked whether he was under any suspicion of inappropriately touching Ms. In and we confirmed that is not the case.

He stated multiple times that he does not believe Ms.

to be intelligent. He said that during the course of the photo
shoot, she never stated she was uncomfortable. He said he had no
further contact with her or anyone else pertaining to her after
she texted him asking him to leave her alone and to not harass
her any longer. He also stated that the remark he made to her
about contacting her boyfriend with the photos was merely a joke
and he had no intention of actually doing that. He also said
that he made this comment in person during the photo shoot.

He said he had a conversation with Ms. It that he felt was an anti-Israel conversation, and he felt that she as a Lebanese hated Jewish people. He said he has deleted all the photos of Ms. It is, but then later he said that some photos may still be on his Instagram. He said he does this type of photo shoot as a hobby and not for a job, and he does not sell the photos. They are for his personal use. He stated "I like to take nude photos of women." He stated "I do what I want without regard for anyone else." Eisman stated multiple times that he is mentally unstable and that he has autism and is on medication for it. He alluded to purchasing a gun at a local gun store and then said that I should "be careful," although he said this was not a threat.

Eisman was animated and angry during the phone conversation. At the end of the initial phone call (20 minutes), he abruptly hung up on us but then called back about five minutes later. Upon calling back, he stated that he had just contacted his attorney and that the attorney laughed at the whole situation. Eisman then expressed that there must be no further contact by us and to contact his attorney instead. He hung up again, so we texted him to ask for his attorney's information. Then he called back a third time stating he actually had no legal representation because his attorney was not licensed in California, and that he was also broke. He said "I have no money and I am unemployed, and during the last five months my life has gone to shit." He also said during this phone call that he did not trust himself with a gun, and he had actually canceled his appointment at

the gun store. He made multiple remarks about being suicidal and wanting to kill himself. He stated that he will "run into traffic", and we "should see [him] off of his meds."

In the same section of the third conversation, he said that he had Googled our office location here at 118 South Blvd. in San Mateo, and that he will come here to kill himself in front of us. He asked: "is that something you want? Do you want to deal with this level of crazy?" I said no, we would not want him to kill himself at our office. Eisman did not specify when exactly he will come to our office and kill himself.

After stating all of this, Jordan said he has taken all photos of Ms. down and has completely deleted his Instagram account. He stated "that dumb bitch scared me!" He reiterated that he has no money and no job, and that we will not be able to get anything from him since he is judgment-proof. He again declined the offer to receive a copy of his statment for review. He then ended the call by saying "are you happy now? Go fuck yourself." Then the line went dead. We received a text message a few minutes later stating that Eisman took half a bottle of Xanax and that we might be hearing from the police at some point (presumably, he referred to his suicide).

Conclusion

Eisman committed at least three crimes, some with multiple counts, and he is a danger to himself and others. I would recommend a field interview and appropriate enforcement action.

Upon calling Jordan, I identified myself as an investigator acting on behalf of Andrew Watters, and I asked if we could talk about the incident that took place on the indicated date. He was surprised and asked "what incident?" I informed him that was what we were trying to determine. Jordan went on to state, without being prompted, that on June 22 he paid to take nude photos of her, that he had her consent, and that there was no physical contact at all. He also stated that as of now, he has taken off all the pictures from his Instagram that she asked him to remove. He also stated that he would have no problem removing any additional photos at her request; he said he had already removed the two photos that she said that were distasteful.

Jordan then asked who we were, and Andrew responded by saying his name ("Watters with two t's"), and that he has a website that Jordan can search for in order to get further details. Andrew said he is an attorney and private investigator, that we were conducting a private investigation, that we were hired by and our goal was not to take sides but to find the truth. Jordan said he was surprised that hired us and immediately stated that he wanted to keep us on the phone as long as possible in order more money. We asked if we could record Jordan, to cost and he declined, so we did not record the call. However, Jordan agreed to keep talking to us so long as we were not associated with law enforcement. Andrew explained this is a civil investigation at this point, and we are not associated with law enforcement. The rapid flow of the conversation was such that Jordan was unwilling to listen to much of what we said, but Andrew attempted to warn Jordan that anything he said could be used against him and this was voluntary on Jordan's part. he took them down anyway without receiving the refund. To his understanding, agreed that he could take nude pictures of her and her vagina for \$200 an hour—the only stipulation was that she would not be spreading her genitalia i.e. "pussy lips." He said during the time that she was at the apartment and taking photos for him, he did show her a couple of the photos and she had no objections. He also stated that he offered to show her all the photos at the end of their session but she declined, saying she had somewhere else to be. He said he does not remember how many photos he took of some lates and stated that they had a prior conversation before her arrival stating that he did want pictures of her vagina and would like her to be shaved. She responded by saying that she was not "fully groomed down there, but he would see upon her arrival at his apartment."

He said that started contacting him after the photo shoot due to the fact that her boyfriend was upset and wanted the pictures taken down. To Jordan's understanding, the boyfriend did not know what was doing, and when he found out he got upset. That's why Jordan believes asked for the pictures to be taken down. He did inquire as to whether we had seen payment receipts or the actual messages that were on Instagram. He stated that he deleted all his messages on Instagram and that he did not think that was smart enough to know that Instagram messages can be retroactively deleted.

Jordan stated that he has worked with 32 models and has been in the field for one year, and he has never had any issues pertaining to this before. He also stated that his father has been in the photography industry for 50 years. He said he paid in full via PayPal. He said he agreed to not ask her to open her legs, or to take any pornographic photos. He did say that pornographic photos to him is seeing or spreading "pussy lips" and this did not occur. He asked whether he was under any suspicion of inappropriately touching and we confirmed that is not the case.

He stated multiple times that he does not believe to be intelligent. He said that during the course of the photo shoot, she never stated she was uncomfortable. He said he had no further contact with her or anyone else pertaining to her after she texted him asking him to leave her alone and to not harass her any longer. He also stated that the remark he made to her about contacting her boyfriend with the photos was merely a joke and he had no intention of actually doing that. He also said that he made

this comment in person during the photo shoot.

He said he had a conversation with over the phone that he felt was an anti-Israel conversation, and he felt that she hated Jewish people, claiming she was racist. He said he has deleted all the photos of her, but then later said some photos may still be on his Instagram. He did say he does this type of photo shoot as a hobby and not for a job, and he does not sell the photos. They are for his personal use. He stated "I like to take nude photos of women." He stated "I do what I want without regard for anyone else." He stated multiple times that he is mentally unstable and that he has autism and is on medication for it. He alluded to purchasing a gun at a local gun store and then said that Andrew, an attorney, should "be careful", although he stated this was not a physical threat.

Jordan was animated and angry during the phone conversation. At the end of the initial phone call, he abruptly hung up on us but then called back about five minutes later. Upon calling back, he stated that he had contacted his attorney and they laughed at the whole situation. Jordan then expressed that there must be no further contact by us and to contact his attorney. He hung up again, and I texted him to ask for his attorney's information. Then he called back for a third time stating he actually had no legal representation because his attorney was not licensed in California, and that he was also broke. He said "I have no money and I am unemployed, and during the last five months my life has gone to shit." He also said during this phone call that he did not trust himself with a gun, and he had actually canceled his appointment at the gun store. He made multiple remarks about being suicidal and wanting to kill himself. He stated that he will "run into traffic", and we "should see [him] off of his meds."

In the same section of the conversation, he said that he Googled our office location here at 118 South Blvd. in San Mateo, and that he will come here to kill himself in front of us. He asked: "is that something you want? Do you want to deal with this level of crazy?" Andrew said no, we would not want him to kill himself at our office.

After stating all of this, Jordan said he has taken all photos of down and has completely deleted his Instagram account. He stated "that dumb bitch scared me!" He reiterated that he has no money and no job, and that we will not be able

to get anything from him since he is judgment-proof. He again declined the offer to receive a copy of his statment for review. He then ended the call by saying "Are you happy now? Go fuck yourself." Then the line went dead.
