OBJECTION NO. 1

Declaration of Harald Herchen, in its entirety.

Grounds: Incompetent Evidence; Lacks Foundation; Inadmissible Opinioin/Conclusion

Harald Herchen gave false testimony in his October 29, 2020 deposition under oath. The credibility and admissibility of Defendant's testimony is in question given he is an admitted perjurer. The trier of fact may disregard all of the testimony of a party if it determines that he testified falsely as to some matters covered by his testimony (Evid. Code §780; CACI 5003; *Nelson v. Black* (1954) 43 Cal.2d 612; *People v. Lavergne* (1971), 4 Cal. 3d 735). The declaration 'evidence' relied on by Defendant – his own self-serving declaration – accordingly lacks foundation pursuant to Evidence Code section 702, and consists of Defendant's own self-serving conclusions rather than material facts supported by evidence. His Declaration is accordingly incompetent evidence of any material facts stated therein to support summary judgment or adjudication.
