Dear Mr. Banasik,

As I am sure you are aware, there is now a Federal lawsuit against you in the Northern District of California that I filed over the weekend, case no. 5:24-CV-01816-EJD.

I substitute-served your Mom today 3/27/2024 in the parking garage of your apartment building. She confirmed she lives with you. I have video of the serve in which I gave her the papers, as well as a photo taken after the fact proving that she took the papers a few minutes after initially throwing them on the ground. This is valid substitute service under the law because we previously attempted on you directly several times, and no one answered the door at your home.

Please see attached courtesy copy of the papers in the service package, which is also being mailed to you today per your Mom's request.

Note there is a Temporary Restraining Order against you requiring you to restore my client to her rightful control of the Qyral accounts and I.T. infrastructure immediately, and also restore the funds you took; and additionally freezing your bank transactions.
