Petitioner's Request for a Domestic Violence Restraining Order, filed on August 3, 2026, was heard on September 16, 2026, at 8:30 a.m. in Department 32 of the Southern Branch of the San Mateo County Superior Court, with Judicial Officer Brooke Murphy Kent presiding.
